# 20/68. MINUTES OF THE LAST MEETING.

# 20/69. PROGRESS CHECK.

A brief update on matters arising from the last meeting.

 Tree Planting Project – the ECC scheme is hoping to work with the parishes sometime this year.

### 20/73. UPDATE FROM CLLR CRISCIONE.

To receive an update from Cllr Criscione following meetings with the Police, ECTU, ECC & UDC regarding:

- The existing problem with crime and disorder at the site.
- Environmental issues with regard to regular fires, loose dogs, goats and horses. It was explained that there was no dog warden at UDC and that the site is the sole responsibility of ECC.
- The future of the site where alternatives may be available; the appropriateness of the site is being looked into.

### 20/74. PLANNING.

**Appeal Ref: APP/C1570/W/19/3228069.** Land at Pound Hill. The appeal is allowed and planning permission is granted for 18 dwellings, vehicular access, public open space, sustainable drainage systems, structural landscaping and infrastructure Ref: UTT/18/0440/OP, dated 6 February 2018.

 An update on the demolition of the Moors bungalows – the contractors are still removing asbestos, work is progressing. Agreed that the green must be restored and bollards installed so the Parish Council can take over the future maintenance.

# 20/75. STREET-LIGHTS.

As no other quotes have yet been received it was agreed to replace the one faulty streetlight with an LED lamp.
