MINUTES OF A MEETING OF LITTLE DUNMOW PARISH COUNCIL HELD ON MONDAY 14 MARCH 2022 AT 7.30 PM AT THE RECREATION GROUND MEETING ROOM, BROOK STREET, LITTLE DUNMOW

22/27. APOLOGIES FOR ABSENCE.

There were no apologies.

22/28. MINUTES OF THE LAST MEETING.

The minutes of 10 January 2022 were approved as a correct record of events.

22/29. PROGRESS CHECK.

No matters were raised.

22/30. DECLARATION OF INTERESTS.

To receive any Disclosable Pecuniary Interests, Other Pecuniary Interests, or Non-Pecuniary Interests relating to items on the agenda. No interests were declared.

22/31. PUBLIC FORUM.

Residents were concerned about the amount of rubbish from the red bins belonging to the Flitch of Bacon which are sited on the land opposite which could attract rats. There are also two dumped fridges. Residents have complained to UDC Environmental Services. It was suggested that the bins could be hidden from view and that they should be regularly emptied. Cllr Guild agreed to contact the restaurant owner. It was also questioned whether planning permission should have been sought to use the land opposite as a car park and do they have permission to site the bins on that land.

Other matters raised; the pond opposite the Flitch of Bacon, although the Parish Council would like to maintain this area the owner has refused permission. The lights on the new houses at the Moors were considered very bright, the Housing Association to be contacted regarding this.

Agenda Item 22/40. Footpath between nos. 2 and 3 Brook Street. Agreed to contact the ECC Ranger to see if the French drain could be extended so that any water running off the Flitch Way could then run into the nearby stream. The path is currently unusable due to flooding.

Location: Moors Fields, Station Road, Little Dunmow.

The Parish Councils objections remain the same and are to be re-submitted.
