23/06. APOLOGIES FOR ABSENCE.

23/07. MINUTES OF THE LAST MEETING.

23/08. PROGRESS CHECK.

The draft Landscape Survey has just come through. Flitch Green are not going to do a Neighbourhood Plan. It is possible that a referendum could be held within the next year.

23/13. CATESBY (MOORS FIELD) 'HOME WORKING HUB'.

To discuss the possibility of the Parish Council taking ownership of the facility. There was discussion around whether the Parish Council could afford to take on the facility, which will be offered to the Parish Council first. Design of the building will take a while, a legal agreement would need to be drawn up. A 'sinking fund' could be set up by the developer to cover operational costs/ongoing maintenance costs. Surrounding land could be put forward as Green Space to protect it from further development. Cllr Criscione agreed to arrange a site visit to a similar facility (Walpole in Stansted) so Councillors could see how it was run.
