Application No: UTT/18/3424/OP. Outline planning application for the erection of up to 240 dwellings with public open space, landscaping and sustainable drainage system (SuDS) and vehicular access point from Station Road. All matters reserved except for means of access.

Location: Land east of Station Road, Little Dunmow.

A letter objecting to the application will be drawn up by the Clerk and circulated to Councillors before submitting it to UDC Planning Department.

Application No: UTT/18/0440/OP. Outline application, with all matters reserved except for accesses and structural landscaping, for a residential development comprising up to 18 dwellings (use class C3), vehicular accesses, public open

space, sustainable drainage systems and all other associated hard/soft landscaping and infrastructure.

Location: Land at Pound Hill, Little Dunmow.

Application refused for the following reason: The proposal is not in accordance with national and local planning policies and so it is an unacceptable form of development.

The indicative development, in particular the indicative layout, would result in an overdevelopment which would create a non linear and cramped development that would result in an adverse impact on the front street scene and visual impact into the open space beyond and so the proposal would be contrary to Uttlesford Local Plan Policy GEN2.

A meeting with representatives from Enodis has been arranged for Tuesday 22 January at 3.30pm to discuss the application.
